

Emergency Shetter

Known as My Friend's House, our emergency shelter serves youth 0 to 17 who come to us through community referrals & CPS. The shelter provides:

- 24-hour care
- Life skills classes & enrichment
- Medical, dental, & educational support
- Individual, family, & group therapy

Transitional ( iving

Designed to serve 18 to 22-year-olds, the Transitional Living Program provides a safe place for individuals to reside as we assist them in working toward long-term goals and living independently. Residents receive:

- Case management & therapy
- Life skills classes & enrichment
- Academic & employment support



# HOW WE SERVE

Street Ontreach

Our Street Outreach team connects with homeless youth where they are. The Youth Resource Center provides a place for individuals ages 16 - 22 to access:

- Case management & therapy
- New clothing & laundry services
- Showers & meals
- Computer & Wi-Fi access







## STORIES OF US

Alex<sup>\*</sup>, 6-years-old, was referred to City House because his parents recently separated and there was lots of conflict in the home. As a result, he was having nightmares, separation anxiety and crying outbursts multiple times a day.

After receiving counseling with one of our therapists, his outbursts have decreased, and mother reports no outbursts in the last 3 weeks! Alex\* is effectively using a coping strategy that our therapist taught him:

Tree Breathing! Imagine you are a tree, stretch your arms out wide – these are your branches, take a deep breath and blow all the leaves off your branches.

Mother reported Alex<sup>\*</sup> has been doing well using his coping strategies when upset and doesn't even need prompting anymore!

Marissa, 16-years-old, experienced sexual abuse by her grandfather, was facing housing insecurity, family conflict and had little connection with her mother. She exhibited chronic running away behavior, was sexually assaulted while on the street, got pregnant and tried to care for her child but did not have the support she needed. She gave the child up for adoption.

When Marissa came to MFH, neither mom nor client thought reunification was possible. Intense case management was provided including support, clear expectations, and structure. Individual, family, and group counseling was also provided. As a result, Marissa began to process the trauma she experienced and re-connect with her mother.

She has now reunified with family and has continued to participate in individual 8 family counseling weekly since being discharged from our care.

Zach, 18-years-old, came to the drop-in center after being kicked out of his mom's house recently due to conflict. He had been sleeping outside for several weeks. SOP staff were able to provide him with food, clothes, a shower, gift cards, a backpack, a sleeping bag, a tent and bus passes. Zach returned several days a week to meet with his SOP case manager. They worked diligently to help him attain his birth certificate and social security card. They also transported him to the DMV to finally gain his state ID. With those documents, Zach was able to gain stable employment. As an African American young man, Zach related to the SOP staff member, who is also African American. They were able to discuss the challenges he faced in his life, his goals and even develop a plan for improving his mental health and coping skills. He said that helped build a motivation in him that he never had before. As he worked on himself, his relationship with his mom improved and he was able to move back home. Now he is beginning to look for his own apartment.


